## **About GMPA**

Global Migration Policy Associates support, encourage and generate knowledge and analysis for a broad-based international defence of the rights-based approach. It challenges and articulates an alternative to the instrumental cost-benefit logic of social analysis, of "human resource management" and of 'migration management' that have predominant, including among those who consider themselves humanitarian in their worldview.

GMPA comprises a unique cooperative network among preeminent migration experts across all regions of the world. Members reflect diverse academic and practical disciplines addressing the multiple aspects and impacts of migration. Its members possess knowledge, experience and commitment to human rights necessary to challenge the rationale that exclusion is the collateral cost for national and international development.

In order to 'make a difference' in this context, GMPA is focused on articulating an analysis and knowledge base independent of the dominant framework while supporting partner mobilization around common, strategic activities and actions.

# **GMPA's comparative advantage**

We represent and give life to a rights-based agenda rooted in advocacy, practice and the experience of migration worldwide. We give emphasis to migrants as human beings first and foremost, addressing discrimination and equality of treatment for all migrants and immigrants. We offer alternatives to emphasis on migrants as "agents of development" who are praised for their utilitarian value but encouraged to trade away universal rights in exchange for presumed development gains. We uphold human rights, democratic approaches and social justice as defining principles for migration whether circular or permanent, and promote leadership and action by government, civil society and migrant communities.

#### GMPA: TEN ACCOMPLISHMENTS IN FIRST FIVE YEARS 2011 to 2016

- 1. Attracted 45 of the 'best and the brightest' migration professionals, practitioners and academics worldwide into a membership network, with regional, ethnic, gender, topical and disciplinary diversity.
- 2. Conducted substantial and significant activity
  - knowledge building: conducting, producing and/or collecting research studies, published articles, policy briefs, conference papers, policy analyses, etc. (lists in annual reports)
  - public events: seminars, conferences, side events to major international conferences, etc.
    - 1 seminar type side event to the Human Rights Council per annum, two of which drew 70-80 participants (large numbers by usual side event attendance)
    - 1 to 2 substantial seminars or sessions of major conferences (one characterized as the largest event ever at UN Geneva on migrant women and human rights)
    - 1 event per year organizing presentations of numerous academic papers.
    - Elaborated GMPA policy documents for partners and civil society forums, such as PGA, GCM
    - Engaged in several significant international research or technical cooperation projects
  - Provided training sessions and co-organizing training course for and in ACP countries
- 3. Established and updated a highly appreciated and widely-accessed website information platform
  - 1. Over 200 substantial documents, reports, papers, briefs posted
  - 2. Average monthly hits up to 10,000, average daily 50 document downloads
  - 3. Numerous positive comments by reviewers on presentation as well as content
  - 4. Evidently used by other actors as a model.
- 4. Established and maintained an operational secretariat, with usually three full time staff since 2013
- 5. Effectively institutionalized the Association
  - 1. Formal constitution
  - 2. Legal registration and recognition
  - 3. Developed operating procedures
- 6. Obtained UN ECOSOC NGO accreditation «in record time».
- 7. Built up and operationalized a global contact and communications data base comprising over 5,000 entries including professional identity info and complete address profiles, most tagged into several of 110 geographic, organizational, professional, and topical discipline category lists. (GMPA is able to send mass info mailings with document links to some 4,000 up-to-date contacts.)

# In consequence:

- 8. GMPA associated activity has concretely influenced and/or affected law, policy and practice in several states (Afghanistan, Bangladesh, Nepal, Nigeria, Sri Lanka); at the regional level in Africa and Asia, in a major Regional Organization –the African Union, has contributed to discussion in the OSCE, and played an influential role in several international conferences on migration issues.
- 9. GMPA is perceived and acknowledged as a serious and relevant actor among civil society organizations, some academic institutions, the UN environment in Geneva, and by certain international agencies IOM, ICMPD, OSCE, ILO and several government missions in Geneva. (It may also be perceived as a challenge for certain civil society, institutional, and government actors.)
- 10. The GMPA effort contributed to resetting a *rights-based* pole in the international migration arena.

The launch event was organized by Caritas Europa and hosted by Cecila Wikström, Sweden, Member of European Parliament (MEP), ALDE group, and included remarks by Shannon Pfohman, Advocacy Officer, Caritas Europa and Marta Cygan, Director of Strategy and General Affairs Directorate, DG Home, European Commission; Jean Lambert, MEP, UK, Greens group; Roberta Metsola, MEP, Malta, EPP group; Oliviero Forti, Caritas Italiana. Patrick Taran, lead author of the book, presented the publication.

As stated in the foreword to the report by *Jorge Nuño Mayer, Secretary General of Caritas Europa:* 

«This report is Caritas Europa's studied response to the tragedy hundreds of thousands of women, men and children face when seeking refuge in Europe. People escaping war, repression and violation of human rights turn to Europe in the hope of finding a safe haven, but instead meet with denial of protection and rejection of solidarity. With this report, Caritas Europa wants to contribute to this political debate and propose solutions to the ongoing tragedy of migration. It is based on the experiences of Caritas organisations across Europe working to secure protection and human rights of migrants and refugees. The stories and testimonies of those who make it to Europe demonstrate the urgency of the situation."

# THE EXPERT MEETING CITIES WELCOMING MIGRANTS AND REFUGEES ATHENS, 23 NOVEMBER 2016


GMPA assisted in organizing and preparing the Expert Meeting *Cities Welcoming Migrants and Refugees* held 23 November 2016 in Athens, Greece following the Athens High Level Meeting on 22 November. The Expert Meeting was co-convened by UNESCO, the Marianna V. Vardinoyannis Foundation and the European Coalition of Cities against Racism (ECCAR) in support of local governments on the *front lines* in the reception of refugees and migrants, in context that some 80 percent of all refugees and migrants live in cities and urban settlements. (Nearly half of the total population of 244 million international migrants worldwide in 2015 resides in ten highly urbanized, high-income countries, of which five are in Europe.)

Some 40 experts participated, including municipal mayors, city government officials, civil society practitioners, academics including UNESCO chairs, and international organization officials (OHCHR, IOM, UNHCR) from around Europe and from Canada and the USA. The meeting was opened by a panel session with seven mayors from cities around Greece.

The Expert Meeting advanced preparation of a practical Handbook and a local governance framework to better equip municipal authorities and key stakeholders with knowledge and capacity for reception, inclusion and integration of refugees and migrants. **Gabriela Neves de Lima** and **Patrick Taran** of GMPA participated.

# LAUNCH OF FLAGSHIP BOOK: CITIES WELCOMING REFUGEES AND MIGRANTS AT THE ATHENS HIGH LEVEL MEETING ON REFUGEES AND MIGRATION 22 NOVEMBER 2016





An integral part of the Athens High Level Meeting on Refugees and Migration 22 November 2016 was the launch of the publication "Cities Welcoming Refugees and Migrants: Enhancing effective urban governance in an age of migration". Some 50 journalists and observers attended the press conference launch, including local, national and international radio, television and print media reporters.

UNESCO Director General **Irina Bokova** offered opening remarks highlighting the commitment of UNESCO to upholding the protection of human rights and social inclusion of all persons everywhere, especially in cities and urban settlements where most refugees and migrants reside. **Marianna Vardinoyannis**, President of the M.V. Vardinoyannis Foundation, underscored the urgency of protecting refugees and ensuring dignity and decent treatment for newcomers to our cities. Lead co-author of the book, **Patrick Taran**, provided an overview of the context for the book and outlined its main features.

Researched and co-authored by **Patrick Taran, Gabriela Neves de Lima** and **Olga Kadysheva** of GMPA, it contains a thorough mapping and analysis of issues, experiences and responses by cities across Europe to refugee arrivals and immigration. The book identified a common governance policy and practice framework implemented by cities across Europe.
